My first memory of Milwaukee as the plane was landing, was the Caribbean blue waters of Lake Michigan and the cream color bricks of the city.

Shortly into my career in private practice, Lisa began to mentor me and stress the importance of not only delivering great care for patients, but also the importance of advocating for our profession by joining organized dentistry. As a result, I joined the GMDA Board in 2019 and also began teaching part time in the graduate periodontics program at Marquette University. The first thing that I realized

being on the GMDA board, is that I was extremely blessed to be surrounded by such passionate individuals that want to protect our field. I did not realize how much work goes on behind the scenes for passing bills and setting up discussions about political topics in dentistry.

During my time in the GMDA some of the powerful accomplishments that I have seen through organized dentistry was the ADA response to the pandemic, deeming dentistry as an essential healthcare service, vaccine administration to help our community, and various other accomplishments. As a continuing result of the pandemic, we continue to have major impacts on our profession. Some of the current challenges that we are seeing in our local dental communities is the declining numbers of office employees including dental hygienists and assistants, demand for higher pay rates for these employees, and continuing decreased reimbursement rates from dental benefit providers. In response to these labor shortages, GMDA has begun discussions with the Department Chair of Hygiene, Director of Clinical Education and Compliance, and Program Coordinator for assisting at Milwaukee Area Technical College to see how GMDA can support our dental community.

DENTAL ASSISTANTS THE 2022 VISION

The shortage of dental assistants is increasing and dentistry is suffering. I have been in the dental industry for more than a decade. From dental assistant to dental educator, I can see the gap between dental assistant training, job opportunities and dental offices that partner with schools.

Since I began this position, I have been doing community outreach and program promotion, especially with high schools. It is very important to promote and advocate for our program since most don't know enough about the field to pick it as a career path.

Our program at Milwaukee Area Technical College has state of the art dental equipment, digital imaging, and very well-trained instructors that prepare our students to the best standard in the dental field. Our college also has a bilingual dental assistant program, which opens the opportunity to our Hispanic community to go to college, ultimately benefiting the dental community.

We are aware of the new bill (254) that was passed by the Wisconsin Legislature in 2021 establishing the Expanded

Function Dental Assistant. This will bring a totally new chapter for the dental assistant profession. Dental Assistants programs have a bright future, but we need to work together, stay connected, support our technical colleges, and promote our programs to solve the shortage.

Advocate for dental assistant programs by encouraging patients, your family, and friends to consider it as a career option. Let's recognize that assistants are a valued member of the dental healthcare team.

Dentists and everyone in our dental community, we need your help and support. Our students have great potential. We must give them the opportunity to become a professional dental assistant. You can help by taking the time to have a clinical partnership with MATC by hosting a student for an internship/clinical rotation. Private dental offices are part of the training of our dental assisting students. Consider being a mentor to these wonderful students, by providing them an opportunity to be part of your team and participate in the different areas of the dental office. It is a great opportunity to train a possible employee for your office.

Lastly, I would like to mention that, as a part of the Dental Assistant Association, I am actively involved in the creation of the Greater Milwaukee Dental Society, which hopefully will create networking opportunities and be a great way to support and promote the dental assistant profession.

Region 3 Trustee Report By Drs. Angela Lueck and Cheska Avery-Stafford

There are likely very few industries not affected by staffing issues right now. Marquette University School of Dentistry has a shortage of instructors, both full and part-time. The WDA is working to fill the Director of Government Service's position. And we are all acutely aware how many of our member dentists are struggling to find skilled dental assistants or hygienists.

Our local dental components have been meeting with the directors of the hygiene and assisting programs at our technical colleges to help better understand the shortage and the limitations that exist in educating more qualified individuals.

The WDA President, Dr Cliff Hartmann, has spearheaded the Dental Team Workforce Shortage Workgroup to address our concerns and they are making slow, but steady progress. We thank those that are donating their time to be part of this workgroup. We hope that there is more positive news on this front in the near future.

For those that are graduating, whether dentists or auxillary support staff, the Department of Safety and Professional Services has launched **LicensE** on May 16th. This is a new self-guided, online occupational license application platform which should speed up new license processing times. This platform will also be used for renewals starting in July.

The Dental Examining Board (DEB) met in May for their first inperson meeting in two years. Now that Wisconsin Act 254, Certification of Expanded Function Dental Auxiliaries, has been signed into law, the DEB will begin promulagating rules. The first step in the process will be developing a "Scope Statement". It will then go to the Governor for his approval. A public hearing will be scheduled before the DEB writes the rules. Once written, technical schools can develop curriculum and establish training programs. The process will likely take two to three years to complete.

The WDA Foundation was established in 1957. Its mission is to improve the oral health and overall well-being of Wisconsin Residents. In May, \$55,315 in grants were awarded to twelve charitable oral care programs to support the dental needs of Wisconsin residents.

The WDA recently held a strategic planning meeting on May 6th which included the executive board, several trustees, WDA committee members, staff and member dentists from across the state. The meeting was facilitated by ADA staff and provided an opportunity to evaluate the current status of the association and welcome input regarding what is going well and what can be improved. This information will be analyzed and then presented to the House of Delegates for approval. Overall, the meeting was successful and reinforces the significance of member participation. Topics discussed include workforce issues, membership and market share as it relates to practice models and improving communication with members and the public.


