- Recommendation for 3 Advisors that will work together to ensure adequate coverage at each meeting (at least two advisors present) and be available to assist the board in making decisions by providing background information when needed.
- Not a voting member
- Familiar with basic Parliamentary procedure
- Provides guidance in matters of the Election/Ballot annually
- Assists with interpreting GMDA Bylaws
- Attends at least 50% of GMDA Events
- 3 year term with no term limits

NEW LAW U.S. Beneficial Ownership Information

Registry Now Accepting Reports

Existing Companies must file by Jan 1, 2025.

New Companies Must File Within 90 Days of Creation or Registration

WASHINGTON –U.S. Department of the Treasury's Financial Crimes

Enforcement Network (FinCEN) began accepting beneficial ownership
information reports. The bipartisan Corporate Transparency Act,
enacted in 2021 to curb illicit finance, requires many companies doing
business in the United States to report information about the individuals
who ultimately own or control them to protect our economic and
national security. According to Secretary of the Treasury, Janet L. Yellen,
"Corporate anonymity enables money laundering, drug trafficking,
terrorism, and corruption. It harms American citizens and puts lawabiding small businesses at a disadvantage. Having a centralized
database of beneficial ownership information will allow us to tackle the

Filing is simple, secure, and free of charge.

Beneficial ownership information reporting is not an annual requirement. A report only needs to be submitted once, unless the filer needs to update or correct information. Generally, reporting companies must provide four pieces of information about each beneficial owner:

scourge of illicit finance enabled by opaque corporate structures."

- name
- date of birth
- address
- the identifying number and issuer from either a non-expired U.S. driver's license, a non-expired U.S. passport, or a non-expired identification document issued by a State (including a U.S. territory or possession), local government, or Indian tribe. If none of those documents exist, a non-expired foreign passport can be used. An image of the document must also be submitted.

FinCEN's <u>Small Entity Compliance Guide</u> walks small businesses through the requirements in plain language.

The WDA House of Delegates took place November 8th-9th in Eau Claire. We would like to thank all of the Region 3 delegates/ alternates that participated: Drs. Emily Eckdahl, Marybeth Francis, Geoffrey Ganzman, Charlie Krenzke, Swathi Golla, Tom Raimann, Mike Grady, Bridget Mackey, Rick Mueller, Sirisha Pulapaka, Katie Satula, Nicole Sawatzke, and Charles Stoianovici. Please thank them for dedicating their time and efforts in helping to serve the members of the WDA and Region 3.

Dr. Avery-Stafford served her final year in her 2nd three-year term as Region 3 Trustee and she has now been elected at the WDA Vice President. Dr. Charlie Stoianovici is now your new Trustee for Region 3 along with Dr. Angela Lueck, who has one year left on her 2nd three-year term as Trustee. If you are interested in becoming involved as a future Trustee, please reach out to us to answer any questions and let us know you are interested.

Two thirds of WDA's Legislative and Administrative Policy Guide has been reviewed and updated and the final one-third will be completed by the 2025 HOD and then reviewed periodically in the future to keep the guide up-to-date.

Legislative priorities for the upcoming year include Virtual Credit Card, Network Leasing, Medical Loss Ratio, Special Needs Adults, as well as the scope for Expanded Function Dental Assistants.

An update on EFDA programs: CVTC-Eau Claire has graduated 2 cohorts already, with up to 5 cohorts/year. Madison, WTC-La

Crosse, and MATC began programs this fall with FVTC-Appleton, NTC-Wausau, NWTC-Green Bay, WCTC and Northwood-Rice Lake beginning in 2025.

As a result of the WDA's legislative successes of 2023-2024 the state's technical schools received 20 million dollars to dedicate to increasing the numbers of dental auxiliary programs throughout WI. This will allow our technical colleges to graduate 200 more dental auxiliaries/year which includes assistants and hygienists to help with the shortage throughout the state. There will also be three new hygiene programs which have opened or are planning to open soon.

The WDA plans to launch a member-only Facebook group in 2025 as well as a texting platform. We can also look forward to a Dental Day at the Zoo in 2025.

Three of our GMDA members were inducted into the Pierre Fauchard Academy breakfast on Friday, November 8th: Drs. Emily Eckdahl, Swathi Golla, and Charles Stoianovici.

A HUGE CONGRATULATIONS to our past WDA and GMDA President, Dr. Monica Hebl, who won the ADA's 9th District Trustee position. We know that she will well represent the members of both Wisconsin and Michigan at the national level.

Our new WDA President, Dr Thomas Reid gave a wonderful speech at the HOD meeting where he provided two memorable quotes: "If you can't love yourself, how in the hell are you going to love somebody else" RuPaul, and "Love thy neighbor as thyself" from Matthew Chapter 22. As we enter into this holiday season, please remember how much we have to be thankful for and how blessed we are.
